**Quilt Show Report:** Alex has been in touch with EBHQ since the Board initially agreed to postpone the show until 2022. EBHQ has gone ahead and confirmed their Show for March 2022 so this has left us with a conundrum. Should we go for a different month in 2022 resulting in area quilters and vendors having three shows in one year (us, EBHQ and PIQF) or should we wait a full two years more and postpone to 2023? Having weighed the options I reluctantly recommended to the Board that we postpone until 2023, and they reluctantly agreed with me. I will therefore be following up with our venue, Joe Cunningham and Barb Strick about this change.

**Community Outreach Report:**

Epiphany Project now has a total of 852 blocks with Maren having contributed a total of 162 blocks. So far she's the winner of the "most blocks" award.

We will have regular kits available, quilt tops that need finishing and best of all the Liberated Cross blocks ready to be assembled into tops for pick up!

If you have any completed Liberated Cross Blocks, please turn them in now so we can wrap up this project. Thank you everyone for helping us meet our block goal.

Other completed quilts and finished blocks can also be dropped off at this time.
